She told me no, she would see her on Friday. I again told her Leigh would not be here as the family was going camping. She became very angry and told me Leigh was not to leave town. She then told me she had an appointment for therapy with Leigh on Friday. I reviewed with Lisa that we needed at least a 5 day notice, as we had discussed before, so we could arrange for the children to be at therapy appointments. She accused me of not wanting her to have her children returned to her.
