can help me!!!

PLEASE HELP ME. My name is Dierly Kingston. I am
15 years old. My parents are Heidi Foster & Daniel
Kingston. Judge Andrew Valdez took me and my brothers
and sisters away on October 19, 2004. He took
my two sisters Stephanie and Andren, February
2004. When they took me away, they tried to
make me say my parents abused vs. My parents
Have never abused me or any of my brothers and
sisters. The only abuse we have had has come from the
things Kristen Stewart and Curtis Biles has done and
the things that have happened to me at ARTEC. When
I tell the people at ARTEC that my parents have never
abused us then they punish me.

PLEASE HELP ME. On March 19, 2005, I walked away
from ARTEC WEST Boys section because I was threatened
by a boy twice as big as me and has sexually molested
other kids against their will. He also has very violent
behavior. Staff knows about it I told staff about the
threat against me but they wouldn't do any thing about it
I had to walk away so I could write letters to my family
and the news so they will know what happened to me.

I am going to write a letter to Judge Andrew Valdez

I hope Judge Valdez lets me go Home before any thing else bad happens to me. when I ⁶ get these letters passed out, I will go back to ARTEC, because I don't want any thing else bad to happen to my Mom and Dad and my brothers and sisters. I don't know what will happen to me when I go back but I'm sure it will be pretty tough.

PLEASE HELP ME I am requesting help from anyone that can help me. I cannot get help from my Mom because Curtis Giles lied about her and Judge Valdez ordered me not to have visits with her any more. I cannot get help from my father because Curtis Giles lied about what happened at the visits and Judge Valdez ordered him not to visit me anymore. If I contact anyone I know from my religion or family and they help me Judge Valdez will hurt my mom.

PLEASE HELP ME. I want to finish high school this year so I can start college next fall like I planned. I can still finish this year if they let me. I need my own attorney that will help me get home. I want to be able ~~to~~ associating with my family and friends again. I want to go to church on Sundays again. I want my life back.

Please help me. I have never been in trouble
 with the law. I have never taken drugs. I
 never ~~smoked~~ smoked or drank. I have never tried to
 hurt anyone. The only reason I am being punished
 is because I won't lie and say that my mom + dad
 have abused me and my brothers and sisters. My parents
 have never abused us. People are telling me to
 say that I'm abused by my parents. When I tell them
 I'm not abused and that I want to go home I get
 punished. They are trying to get me to say things
 that are not true about my parents. But I won't.
 People are telling me to lie and there is a
 kidnapping plot + a plot to hurt Judge Valdez.
 This is not true. My family would not hurt anyone.

Please help me get home. I want to go
 home with my mom + dad and my brothers +
 sisters more than any thing in the world. I love
 my family and I miss them very much.
