She informs me that she has contacted you a number of times regarding this matter. Last year I had the occasion to meet with Ms. Toomey on another matter. At that time I was told to be patient, by Mr. Walker.

During that time I have continued to find improprieties of Mr. Ammen's handling Ms. Bierly's case. I have filed requests for information from the DEA in Washington D.C. regarding the issuance of an Affidavit and Probable Cause statement by a state Attorney. Whether it exist is not critical to the matter at hand and therefore I am renewing my request to decide if you are going to refer this matter to the Disciplinary Board.

I am aware of the distasteful task of reprimanding an Assistant Attorney General Assistant Attorney. However, I believe the Bar eventually represents all attorneys without bias. Three years have passed and there has been nothing done except the request for further documentation or the rational that permission needs to be obtained before proceeding. E.g. issues with Juvenile Court Judge O. Johannsen. Every avenue of redress has been explored, but to no avail. The only difference is that apparently Mr. Ammen has been promoted or moved to the Sex Abuse Prosecution instead of Child Protection. Also, rumor has it that he blames Ms. Bierly and others for his failed bid to be considered for a judgeship.

Please let me know what your intentions are. If you decide not to pursue this matter then I request that you so notify myself and Ms. Bierly, At that time we will prepare a formal request to the Disciplinary Committee as provided in the rules of ethics.
