

University of Utah Employee ID [REDACTED]

I began my employment at the University of Utah working for Dr. Marvin L. Rallison as an Executive Secretary in October 1998. I had previously been employed at Intermountain Pediatrics; a pediatric medical office in Salt Lake City, Utah for Dr. Rob Lindsay et al.

The University of Utah Division of Pediatric Endocrinology consisted of Marvin L. Rallison MD; Michael Swinyard MD; Jan Bagley, RN; and myself when I was hired.

Dr. Rob Lindsay worked at Primary Children's Medical Center (PCMC) along with a staff of certified diabetes educators, dieticians, social worker and office support staff running the Primary Children's Diabetes Clinic. Dr. Rob Lindsay worked with the division of pediatric endocrinology physicians Dr. Marvin Rallison and Dr. Michael Swinyard in the diabetes clinics.

Dr. Marvin Rallison was the University of Utah Department of Pediatrics, Division Chief of Pediatric Endocrinology; he reported to the Department of Pediatrics Chairman Dr. Edward B. Clark.

Dr. Edward B. Clark reports to the Dean of the School of Medicine Dr. Lorris A. Betz who reports to the President of the University of Utah. Dr. Lorris A. Betz was appointed the interim President of the University of Utah in 2004.

The Medical Director of Primary Children's Medical Center an Intermountain Health Center facility and the Chairman of the Department of Pediatrics; University of Utah School of Medicine are the same person: Dr. Edward B. Clark.

Dr. Edward B. Clark's office is located in Primary Children's Medical Center (PCMC).

Primary Children's Medical Center (PCMC) an Intermountain Health Center (IHC) was the hospital in which the division of pediatric endocrinology saw patients, both inpatient and outpatient.

The University of Utah Hospital and Clinics (UUHC); The University of Utah School of Medicine (SOM) and Primary Children's Medical Center (PCMC) can all be accessed through interconnecting hallways.

The University of Utah School of Medicine Department of Pediatrics; The University of Utah School of Medicine Department of Internal Medicine; Primary Children's Medical Center Intermountain Health Care and the University of Utah Hospital and Clinics joined together to form the Utah Diabetes Center.

This center would be located on the campus of the University of Utah in Research Park. Each division and hospital would relocate personnel, but would retain employment of each employee. Hospital and clinic personnel, school of medicine personnel and primary children's personnel would remain the same. The medical records, physicians, office staff and personnel would be relocated to the new center. The new center consisted of approximately 65 employees.

Each of these entities would hold a stake portion of the center, provide support and run the center using an administrative director who was governed by an executive council with high-level officials from each area; Primary Children's Medical Center, University of Utah Hospital and Clinics, The University of Utah School of Medicine divisions of Internal Medicine and Pediatric Endocrinology.

The Administrative director salary would be divided between the Department of Pediatrics and The University of Utah Hospital and Clinics. The administrative director would meet with the Chairman of Pediatrics and the Chief Administrator of University of Utah Hospital and Clinics

The Department of Pediatrics recruited physicians and support personnel to gear up for a move to the new center. Rob Nicholes, PNP; David L. Donaldson MD, office support personnel, Dr. Dana Hardin, Mark and Julie Rice, Rosemary Scales, Cheryl Henderson, Joshua Lockwood, Sylvia Turley, Dr. David Snyder.

Dr. Hardin and I became personal friends. I was promoted to Administrative Assistant for the division of pediatric endocrinology to provide support for Dr. Dana Hardin who replaced Dr. Marvin L. Rallison as Division Chief of Pediatric Endocrinology who was in phased retirement.

Dr. Marvin L. Rallison was still in phased retirement; Dr. Swinyard resigned his position; Cheryl Henderson resigned her position; Jan Bagley resigned rather than be terminated.

Dr. Hardin was seeing patients at Primary Children's Medical Center 1-2 half days per week. Dr. Hardin saw endocrine and diabetic patients. She also specialized in cystic fibrosis patients.

Dr. Hardin asked me to go over to Primary Children's Medical Center to visit a young patient who was in-patient and had no visitors. (Jordan Bierly) I went over and took Jordan to see the helicopters, bought him some items in the gift shop and then took him to Dr. Hardin's office. I was told that Jordan had been removed from his home for medical neglect.

I received phone calls from Lisa Bierly who was trying to get hold of Dr. Rallison. I gave the information to Dr. Rallison (by a note left on his desk) Dr. Rallison would still come in a few hours a week. Dr. Rallison faxed a hand written note to Lisa Bierly.

I was called to come over to PCMC by Dr. Hardin who told me Jordan was at PCMC and was asking about me. I believe Dr. Hardin did not want him to sit alone in the waiting room while she talked to his foster mother. I went over to see Jordan; I talked to Jordan while the social worker from the diabetes clinic was in the room with Jordan and his foster mother. They were trying to get Jordan to brush his teeth as he was losing his teeth because of his diabetes and not brushing.

I told Jordan I would buy him a skateboard; he had told me his brother had a skateboard and he would sometimes try and ride it but his brother would take it away. Jordan told me this when we were looking at the helicopter and there were some teenage boys on skateboards by the helipad. I told Jordan if he brushed his teeth two times a day until his next appointment I would get him a skateboard.

I bought a skateboard and helmet and took them to my office in anticipation of Jordan's next visit. I was called by PCMC stating Jordan told them to call me about his skateboard. I took over the skateboard and helmet.

I was present at a division of pediatric endocrinology budget meeting in which Dr. Edward B. Clark asked Dr. Dana Hardin to transfer her grant money (NIH and institutional) to the department of pediatrics to cover the 1 million dollar deficit from the division of pediatric endocrinology. Dr. Hardin argued with Dr. Edward Clark for over 30 minutes on this subject.

Dr. Hardin adamantly refused; Dr. Clark would not take no for an answer.

Dr. Hardin consulted a lawyer, sold her house and started the process of moving out of state. Dr. Hardin told me this was illegal, she would lose all her research grants, the institution would lose their research grant money and she would never be able to get a research grant again.

Dr. Hardin was very upset about Jordan. I saw her cry many times not knowing what to do for him. Dr. Hardin had two boys, one was a year older than Jordan was, and one was a year younger than Jordan was.

Dr. Hardin brought Jordan to the Dinosaur Museum for a dinner sponsored by Pharmacia pharmaceutical company. I do not remember if he was in-patient at this time or if he was in foster care. I was present with my family at this event and my children met Jordan at this time. They had known of Jordan's situation as they were with me when I bought the skateboard and helmet.

Dr. David Snyder resigned his position and moved to Seattle, Washington. Dr. Clark called Dr. Hardin into his office to tell her Dr. Snyder had given his resignation to him. Dr. Clark stated he could "take actions to prevent him from leaving and he could make sure he would not be able to leave" Dr. Hardin was scarred that Dr. Clark knew she was

leaving and was telling her the things he could do to Dr. Snyder so she would know he could do the same things to her,

Dr. Hardin resigned her position before Dr. Edward Clark had any idea she could possibly leave. Dr. Clark lived only a few blocks from Dr. Hardin and he would go by her house when he heard rumors she may leave to make sure her house was not up for sale. The real estate agent who sold the house to Dr. Hardin had a buyer in mind when Dr. Hardin called to inquire about putting up her house for sale and so the house never had a for sale sign posted and the sale went through very quickly.

Dr. Clark threatened Dr. Hardin; he said he would ruin her career and she would never find work anywhere else; but Dr. Hardin had already found another job and was in the process of leaving.

Dr. Hardin resigned stating problems regarding repayment of debt to the Department of Pediatrics from the Division of Pediatric Endocrinology. ~~(Scribbled out text)~~

I visited Dr. Hardin at her home where Jordan was spending the night. I was told that "grandpa" had brought Jordan over to stay with them for a few days.

I helped Dr. Hardin move from her house, helped clean out her fridge and took her to the University Marriott Hotel where they stayed the night before flying to Texas.

Dr. Hardin took copies of documents and told me to contact her if Dr. Edward Clark took any action against me. I also kept copies of documents at home.

Dr. Edward Clark became the acting division chief of pediatric endocrinology.

I was relieved of my financial duties. I was later told by the administrative assistant for the department of pediatrics, who took over my position as administrative assistant for the division of pediatric endocrinology; the chief administrative officer of the department of pediatrics was afraid I would transfer the grants of Dr. Hardin to the University of Texas without their knowledge.

I continued my job duties as before, without the accounting aspect of the division, although I still had access to the accounting system via my computer access.

Dr. Mary A. Murray was recruited to Pediatric Endocrinology and replaced Dr. Dana Hardin as interim Division Chief of Pediatric Endocrinology.

I stayed in contact with Dr. Hardin, bought magazines from her boys, sent first communion gift, Christmas cards, etc. Dr. Hardin probably contacted me once or twice every 6-8 weeks in some form or another.

I received a Christmas letter and picture from Dr. Hardin talking about an upcoming adoption of a former patient, Jordan. (I HAVE THIS LETTER AND PHOTO)

The Development Director and the Administrative Director of the Utah Diabetes Center recruited me to the position of Development Specialist at the Utah Diabetes Center. The three entities; University of Utah Hospital and Clinics; Department of Pediatrics and Department of Internal Medicine would fund this position. The salary and benefits for the Development Director and Development Specialist would be divided between the three and would also include development and marketing money.

I contacted Teresa Jones who was the Administrative Assistant for the department of pediatrics to apply for my position. Teresa Jones replaced me in the position of Administrative Assistant for the division of pediatric endocrinology.

I did not move my physical space at the Utah Diabetes Center although my title and position changed. The development director moved his office to be located near my space.

I received a call from Dr. Hardin stating she would be coming to town to get Jordan as the adoption had come through. She stated the caseworker was giving her permission to take Jordan on their vacation. She asked me to pick her up at the airport. She was going to bring one of her boys, Jerry was taking one of the other boys and they were going to go to DisneyWorld. When they returned from their vacation they would be able to take Jordan to Texas for adoption.

I told Dr. Murray of the adoption, she said she had talked to Dr. Clark regarding the adoption. She did not tell me what his response was.

When I asked later why Dr. Clark would not do something about this adoption Dr. Murray stated "Doctors can adopt children too"

~~I went to the airport and picked up Jordan, Dr. Hardin and one of the boys. We went to the Utah Diabetes Center, Dr. Hardin had spent a lot of time designing the center and had never seen it. (It was around 7:00 PM) We then went to Burger King, to the Utah Diabetes Center and we went to one of her former neighbor's homes)~~

I do not know the exact date, but Dr. Hardin sent me flowers (the next day or so) for my birthday from Jordan and her boys, my birthday was March 8th, and I know when she came back through town and wanted me to come to the airport and have lunch during her layover I could not go because it was my sons birthday, March 17th.

I contacted Penny Satterwhite a research nurse and asked her to apply for a position at the Utah Diabetes Center. Penny Satterwhite became the research coordinator for the division of pediatric endocrinology.

The Development director resigned his position after a very lengthy formal investigation. I participated in the investigation regarding and was assured by the administrative director he would never be rehired by the University of Utah.

Dr. Hardin had been having a hard time with Jordan. She told me she had him in therapy, he had been put in-patient psychiatric care, and she did not know what to do with him. He had threatened her boys and the state said she needed to send him back.

The Parker Jensen case was just beginning and the DCFS was under attack.

Jordan returned to Salt Lake City; and Dr. Hardin called me and cried and cried. She was deeply upset.

I saw Lisa Bierly on the news standing behind Parker Jensen's parents on the steps of the capital building. Lisa was holding a large sign and there was a picture and caption with her name in the newspaper.

I asked Dr. Murray what they were going to do now that Lisa was on the news and Jordan was back. I asked her what was she going to do when people started calling. I asked her what was going to happen to Jordan once he started telling people where he had been.

Response was Dr's Shuffel so he would get confused.
Dr. Murray stated she would be meeting with Dr. Clark the following day and that was the first thing she was going to talk to him about.

Teresa Jones stated that Dr. Murray called her and told her to send out an e-mail immediately. Teresa Jones wanted to know why it could not wait until Dr. Murray came back to the Utah Diabetes Center, but Dr. Murray said it needed to be sent urgently.

The e-mail went to the entire faculty and staff of the Utah Diabetes Center stating we all had been HIPPA certified and we were not to give any information on Jordan Bierly. During HIPPA training we were told over and over of possible criminal actions if we released any confidential medical information. There was no PHI in the subject line, which was a HIPPA violation in itself. (I HAVE THIS DOCUMENT)

Craig Wagoner; Administrative Director of the Utah Diabetes Center and Alan Christianson; Administrative Officer Pediatric Endocrinology resigned their positions at the Utah Diabetes Center after being recruited to Iasis Healthcare Inc. to design and implement a diabetes program.

Kris Hedges replaced Craig Wagoner as the Service Director of the Utah Diabetes Center. The Department of Pediatrics said they did not have the money to support my position and imposed a reduction of force. They used 4 weeks severance instead of 4 weeks notice and made me leave the center upon notice. *w/ security*

According to the division chief of Internal Medicine "Pediatrics rolled over me, I had no choice". University of Utah Hospital and Clinics agreed to the reduction in force as recommended by the Department of Pediatrics

I believe Dr. Clark knows I have information regarding this highly suspect adoption but believes I have obtained this information through medical records keeping me silent through HIPPA violation threats,

Dr. Clark would not go after Dr. Hardin because he knows she would bring his illegal accounting practices and the NIH would withdraw all of its funding to the University of Utah.

Dr. Hardin has tried to contact me several times, leaving messages on my home, cell and on my husbands cell phone, stating she needs to speak to me urgently. ~~(I HAVE TWO OF THE LAST PHONE MESSAGES)~~

My over 5 year employment with the University of Utah ended June 18, 2004.
