Dear Congressman Baker,

In September 2006, my friend, Kaye Sperry and I went to meet Michelle Pickens at the FBI office here in Salt lake City, Utah. She told Kaye and I that she had been transferred from Phoenix, AZ because there was so much corruption here in Utah. Michelle had been told about my case and been given documents of evidence that my two youngest children had been illegally taken from me by the state DCFS caseworker, Barry Richards and Paul Amman Assistant Attorney General.

DCFS (Division of Child and Family Services) had received a referral from a doctor whom I had never met before, alleging that I was medically neglecting my 7 year old juvenile diabetic, Jordan. Jordan had never gone into the hospital or insulin shock in my care and had been in good health despite his disease. I didn't find out till years later that the taking of my son, Jordan, and my 2 year old beautiful daughter, Leigh, was taken that I learned the truth-it was all a fraud!

The doctor-Dr. Hardin had wanted to use my son as a "lab rat " for her research and had a \$ 5 million dollar research grant from the federal government. She also adopted my son and took him

to Houston, Texas with her after my parental rights were terminated. (illegally) My whole entire case was a fraud and I have yet to go before a judge with all the evidence I have. The doctor's secretary came out with a 7 page statement saying that the taking of Jordan was a fraud in 2004. Legislators who had heard me testify at the Capitol about a rogue, evil, and malicious Assistant Attorney General, Paul Amman, and the DCFS caseworker, Barry Richards, stole my children, lied to the police, perjured themselves and when I was done it was decided a Legislative audit should be performed on my case (the first audit performed on a single case). The Senators and members of the House were mortified and said what an atrocity this was that these children were taken. The Legislative audit stated, "We cannot justify the state's removal of Jordan and Leigh from the custody of their parents". I still do not have my children after all this.

I was hoping to have some kind of justice with the Salt Lake City special agents from the Office of Inspector General's office who were investigating the doctor and her federal money. Then they went to Michelle with evidence of corruption (which was why she was there). She called me in March 2007 and told me she was going to take the evidence to the U.S. Attorney's Office and talk to them. She talked to

Deputy U.S. Attorney Mark Hirata who, she said told her that they were not going to prosecute the state

actors who kidnapped my children. Michelle stated that I had not been "physically harmed", which was just an excuse for not doing anything on my case. This meeting was after the eight U.S. Attorneys were fired under Attorney General Alberto Gonzales. All 8 of the U.S. Attorneys were looking into public corruption when they were fired.

Congressman Baker, our children are being stolen across the United States for millions of dollars that the states are receiving for Title IV funds and not only are the foster/adopt parents getting money so are the doctors, shelter facilities, psychiatrists, psychologists, court appointed attorneys, Guardian ad Litem and all the others who get rich from these children. The only people who suffer are the natural parents and families of the children-not to mention the trauma these precious children are suffering through themselves. They are ripped from their parents and thrown into a strange place, by strangers they don't know without a court order or warrant and the parents are left with empty arms and the feeling that your heart just exploded in your chest.

Jordan was running around playing with his friends when he was taken for an "Immediate need

of medical care". He was not taken to a hospital or a clinic or to the doctor herself who alleged the medical neglect. My son did not have a medical

emergency. He is still waiting for me to get him back – and I will. My case has been an atrocity and yet I still don't have my children.

Michelle Pickens, who I thought would help me, called me after she went to the U.S. Attorney's office told me that the U. S. Attorney's office would not prosecute the guilty people involved in my case. She also told me in a phone call in April that, " there is no corruption in Utah". I was devastated!!!!!! She had told Kaye Sperry and I that she was here in Utah because there was so much corruption here in the state of Utah !!!!!!

Sir, I have tried to help so many families who have gone through the intolerable suffering at the hands of this state and other states and there needs to be some accountability regarding the illegal seizures of children for federal funds. I have two older boys who were not taken from me and yet my 2 year old daughter was taken because she was a "sibling at risk for medical neglect,"-she didn't have juvenile diabetes like her brother, but she was taken because of it. Paul Amman, Assistant Attorney General, told me to my



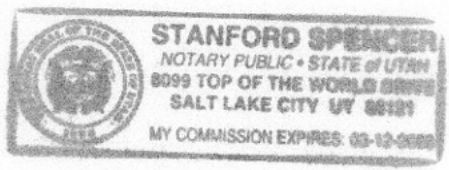

In September 2006, My friend, Kaye Sperry, and I went to see Michelle Pickens at the FBI Office in Salt Lake City, Utah, where we live.

Two special agents were assigned to my case after I had contacted Don White, who is in Public Affairs for the Office of Inspector General for the Department of Health and Human Services under Daniel Levinson, Inspector General in Washington, DC. The agents had the evidence to prove my case and my innocence, which they took to FBI agent Michelle Pickens. This was so that the people responsible for the illegal taking of my children could be prosecuted by the U.S. Attorneys office.

I had been in communication with him for about 6 months and he asked that the special agents look into my case because the Doctor who alleged medical neglect on me had been given a \$5 million dollar research grant to use and my son, Jordan (who had juvenile diabetes) became her "lab rat". Jordan (who was 7 years old at the time), and I had never met Dr.

I hope this helps and that you can do something for these people. Thank You for any help you can give to Lisa and all the others like her who have suffered at the hands of the government not fixing the problems these states are making with these families.
